LISTAHANAN 3 UPDATES



In line with Executive Order 867, S. 2010 which mandates the Department to update the database of poor households every four (4) years, the National Household Targeting Office (NHTO) carried out the implementation of the third round of nationwide household assessment or Listahanan 3. The NHTO and its regional counterparts, the National Household Targeting Sections (NHTS), are directed to conduct the Listahanan 3 as part of its commitment to update the registry of poor households in the country from May 2019 to December 2020.

The implementation of Listahanan 3 is guided by four (4) phases, namely: (i) preparatory; (ii) data collection and analysis; (iii) validation and finalization; and (iv) reports generation and management phase. In adherence to such directive, the NHTO and NHTS implemented the first and second phase of the project cycle in the 2020.

The Listahanan 3 initially targeted to cover 16.1 million households. However, due to the actual administration of the pockets of poverty tool by the NHTS - National Capital Region, a revised national target of 15.7 million was derived.

As of 31 December 2020, the Listahanan 3 has completed its Data Collection and Analysis Phase, wherein a total of 14.5 million households were assessed in 17 regions, 81 provinces, 1,634 cities/ municipalities, and 41,123 barangays.

Among regions, Field Offices III, CALABARZON, and VI are with the highest number of households assessed with 1.41M, 1.37M, and 1.31M, respectively. While whose with the lowest number of households assessed are Field Offices CAR, CARAGA, and MIMAROPA with 245,000, 491,000, and 538,000, respectively.

The registry of households of Listahanan is one of the biggest databases, second to the Census of Population and Housing (POPCEN 2020) being administered by Philippine Statistics Authority (PSA). The coverage of the Listahanan 3 is equivalent to two-thirds or 66 percent of the 21.9 million Filipino households in 2020. [1]

A total of 14,492,065 households (HHs) or 92.3% of the total target were successfully assessed by the NHTS regional field workers through house-to-house interviews. Most of the NHTS regional Field Offices (i.e. I, III, V, VII, VIII, IX, XII, CAR, MIMAROPA, BARMM-BST, and BARMM-LAMA) were able to complete the household assessment before the declaration of nationwide community quarantine due to the COVID-19 pandemic.


Households Assessed



Total targets that were successfully assessed nationwide.


Meanwhile, Field Offices VI and Caraga were able to complete their respective household assessment in December 2019. The other Field Offices (i.e. II, X, XI, NCR and CALABARZON) were only able to complete their household assessment in 3rd and 4th quarter of 2020.

Encoded HAFs



All Field Offices have already completed in data encoding.

Of the number of households assessed, 100% of the Household Assessment Forms (HAFs) were already registered and encoded in the database. All Field Offices have completed the encoding activity in 3rd and 4th quarter of 2020.



The Listahanan is currently on the third phase of the Project cycle or the Validation and Finalization Phase wherein the community is given the opportunity to review the accuracy of the initial list of poor households posted in the barangay. The final database is expected to be completed by second quarter of 2021.###
